Training Development

Is your jurisdiction ready to handle a surge in resource requests?

Do you have trained Logisticians?

Do you know where you can find the logistics training your jurisdiction needs to be prepared?

Beginning this October the Regional Logistics Program is pleased to offer Disaster Logistics training designed to expand your jurisdiction's capacity for disaster logistics.

The training program consists of a modular series of four web-based courses that, in total, take no more than five hours to complete. All of the web-based courses are complemented by Just-in-Time (JIT) videos between 12 and 15 minutes each. All courses have been designed to provide users with the disaster logistics knowledge they need to step in and assist when they are needed most.

The introductory course, *LOG 101: The Disaster Logician*, teaches the basic principles of logistics and the challenges of disaster logistics in particular. The remaining courses – *LOG 200: Logistics Center*; *LOG 201: Receiving and Distribution Center*; and *LOG 202: Commodity Point of Distribution* - are based on the plans developed by the Regional Logistics Program.

While initially designed as self-paced, web-based training all four courses are also available as instructor-led classroom training. The instructor-led version will allow students to discuss the concepts presented in the plans and better relate them to the specific process found in their own jurisdiction. In addition, those students new to logistics will have an opportunity to meet and learn with fellow future logisticians.

Movement Controller

The *Movement Controller* project is currently underway. A proposed architecture for the tool, including database and information requirements, is being developed and reviewed. This project will use results of the existing Program assessments of rail, air, land and maritime infrastructure to create a recommendation for how to develop a computer application tool that enables logistics personnel to optimize the flow of critical resources into the NY-NJ-CT-PA Project Site following a catastrophic incident. The *ALERT Field Operations Guide (FOG)*, which provides Area Logistics Emergency Response Team (ALERT) members with information that will assist them when deployed to new jurisdictions, is now available on the Program website. The *ALERT Implementation Guidance Document*, which will help local jurisdictions introduce ALERT at home, is in the final stages of development and will be available in Fall 2012. These documents support the development of the ALERT.

Regional Resource Management Solution (RRMS/RIMS)

The *EDXL-RM Research and Evaluation* project is currently underway. This project will use the Emergency Data Exchange Language-Resource Messaging (EDXL-RM) standard to pass resource request messages between regional incident management systems. The EDXL-RM standard provides a structure for sharing resource management data between agencies as resources are requested and deployed in emergencies. The Program is using this simulation as a way to facilitate adoption of the EDXL-RM standard throughout the Region to address problems related to interoperability.
